ASSUMPTION OF RISK & HOLD HARMLESS AGREEMENT

In consideration of being permitted to enter upon the Premises and participate in the Event, the Participant hereby acknowledges the potential dangers involved and expressly agrees to assume all risk of injury, death, or property damage in connection with his/her entry onto the Premises and participation in the Event. **Participant understands and acknowledges that as a condition to his/her participation in the Event, he/she releases, remises, holds harmless and forever discharges King's Home, City of Chelsea & its Police, and their employees, officers, directors, agents, representatives, affiliates, and any parties volunteering on behalf thereof (collectively, "King's Home"), and Championship Racing / RRCA from all liability, actions, claims, damages, costs, fines, penalties, expenses, or lawsuits of any kind arising from or related in any way to the Participant's participation in the Event and entry onto the Premises for such purpose.**

The execution of this agreement constitutes a full and complete release of King's Home for all costs or damages which may be incurred as a result of Participant's decision to participate in the Event.
